To guarantee the possibility of exercising one's right to protect nature and to ensure that everyone may use their freedom of conscience relative to hunting, the following is agreed between the landowner and the Society of the Protection of Wild Animals (ASPAS)

The member agrees:

- 1* To surrender his/her hunting rights to the Society, and to renounce this right in favour of the right to protect wildlife. To not hunt him/herself and to forbid hunting on these grounds.
- 2* To place on the boundaries of their land, "Reserve" notices (1) as soon as they receive the signed agreement, so as to inform others that wildlife must be respected in that area.
- 3* To inform ASPAS of all offences committed. For ASPAS to be able to take legal action, the offences must be the subject of a ONCFS report (or the gendarmerie) or be validated by sufficient proof (photographs, witnesses, etc).

ASPAS agrees:

- 1* To provide technical support to the member for the ecological layout of his land (upon request)
- 2* To carry out administrative steps to forbid hunting on the land and to inform the various parties concerned (members, mayor, hunters..)
- 3* To provide legal assistance to the member (on condition that membership fees are up to date) in the case of offences or various questions.

This agreement may be cancelled by the member, by letter at any time for any reason and by ASPAS when the member has seriously breached the condition of this agreement.

The agreement concerning the reserve is considered valid only if ASPAS membership is renewed each year.
